

Dr. Louis Meuleman is Chair of the Stakeholder Forum for a Sustainable Future, Chair of the Scientific Committee of the European Environment Agency, and Vice-Chair of the UN Committee of Experts on Public Administration. He has an MSc in biology, a PhD in public administration, and is a Guest Professor Politics & Public Governance at Antwerp University and Visiting Professor Public Governance at KU Leuven University. Louis is a former public manager of environmental sustainability at several government levels. He has written books on policymaking with stakeholders (2003), combining hierarchical, network, and market governance styles (2008), and (meta)governance for the SDGs (2018).
